

## RESOLUTION NO. U.A. 2002-10

A RESOLUTION INCORPORATING THE FOLLOWING, WITHIN THE SCHEDULE OF RATES FOR ELECTRIC SERVICE FURNISHED BY FORT PIERCE UTILITIES AUTHORITY, FORT PIERCE, FLORIDA, AS KEPT ON FILE WITH THE BUREAU OF ELECTRIC REGULATION OF THE DIVISION OF ELECTRIC AND GAS OF THE PUBLIC SERVICE COMMISSION, AND AS AMENDED BY FORT PIERCE UTILITIES AUTHORITY RESOLUTIONS NO. U.A. 90-5, 92-2, 95-6, 95-7, 96-5, 96-6 AND 99-12: RESOLUTION NO. U.A. 97-7 ENTITLED CUT SEAL AND TAMPERING, RESOLUTION NO. U.A. 99-3 ENTITLED COMMERCIAL SECURITY DEPOSITS, RESOLUTION NO. U.A. 2002-7 ENTITLED GENERAL RULES AND REGULATIONS GOVERNING THE PROVISION OF UTILITY SERVICE, RESOLUTION NO. U.A. 2002-8 ENTITLED RESIDENTIAL SECURITY DEPOSITS, AND RESOLUTION NO. U.A. 2002-9 ENTITLED SERVICE CHARGES; AND RESCINDING THOSE SECTIONS ENTITLED DEPOSIT POLICY, BILLING PROCEDURES, DELINQUENT ACCOUNTS PROCEDURE, SERVICE CHARGES, AVAILABILITY OF UTILITY SERVICE, CUT SEAL AND TAMPERING FEES, AND LIABILITY FOR DAMAGES ARISING FROM Y2K NONCOMPLIANCE, CONTAINED THEREIN; ESTABLISHING STANDBY ELECTRIC SERVICE RATE SCHEDULE SS-1; AMENDING RATE SCHEDULES OL AND SL; RESCINDING RESOLUTION NO U.A. 99-12 ENTITLED POLICY REGARDING LIABILITY FOR DAMAGES ARISING FROM Y2K NONCOMPLIANCE; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.

**WHEREAS**, Fort Pierce Utilities Authority was created and established by the City Commission of the City of Fort Pierce, Florida, through a referendum election held in said City on May 30, 1972; and

**WHEREAS**, the Charter of the City of Fort Pierce, Florida, Article XII, grants to said Fort Pierce Utilities Authority the power and duty to fix rates to be charged for gas, electricity, water, sanitary sewer, and other utility services sold and services rendered by said Fort Pierce Utilities Authority; and

**WHEREAS**, Section 176 of said Article provides that Fort Pierce Utilities Authority shall submit any rate changes or any changes in the formula by which rates are determined to the City Commission for approval or disapproval;

**Now, therefore, be it resolved by Fort Pierce Utilities Authority, Fort Pierce, Florida:**

**Section I:** The rates for Electric Service furnished by the Fort Pierce Utilities Authority electric distribution system shall be in accordance with the electric tariff sheets attached to this Resolution.

**Section II:** Other Ordinances - All sections of the Charter of the City of Fort Pierce pertaining to Fort Pierce Utilities Authority that have not been deleted or superseded up to and including the changes incorporated herein shall remain in effect.

**Section III:** Upon adoption of this Resolution, the provisions of Section I of this Resolution shall be established as an order of Fort Pierce Utilities Authority and all Resolutions of Fort Pierce Utilities Authority inconsistent with this Resolution are hereby repealed.

**Section IV4:** This Resolution shall become effective on November 5, 2002.
